### Key aspects of the UGC Accessibility Guidelines and Standards:

#### Inclusive Environment:

The guidelines aim to create a disability-inclusive environment for students with special needs, from the admission process to the award of marks.

#### Accessible Curriculum:

The guidelines emphasize equitable access to curriculum, flexible and adaptable teaching methods, and the use of Universal Design for Learning (UDL) to create an equitable classroom.

#### Accessible Library Resources:


Libraries should provide accessible resources and formats to ensure equitable access for all students.

#### Accessibility Audit:

An accessibility audit tool is being developed to assess the performance of HEIs in implementing the guidelines.

#### Support for HEIs:

UGC is committed to supporting HEIs in implementing the guidelines and ensuring that students with disabilities can participate in academic programs.
